- Construct dual 300NB steel pipelines (short portion of the pipelines are buried) from NOSF to tie-in points at Oil Industry pipelines next to Puma / Engen manifolds;
- Drain Oil Industry pipelines to construct new tie-in point, complete with valves;
- Commission the system;
- Removal of camp establishment and finishing off the site after completion;
- The maintenance of the works and all other requirements of the Contractor's defects liability.
