UPSTREAM EXPLORATION

Under the Exploration arm, NAMCOR E&P is actively engaged in exploring oil and gas resources and other energy opportunities, both within Namibia and internationally. We welcome companies and individuals interested in oil exploration-related activities to consider Namibia as their next hydrocarbon investment destination. Namibia offers favorable investment conditions, including:

- Highly competitive petroleum regime.
- A working petroleum system conducive to oil and gas exploration.
- A stable political environment that provides a conducive business environment.
- An attractive fiscal regime designed to incentivise investment in the oil and gas sector.
- Excellent infrastructure including port, road, rail and power
- Top ranking fiscal outlook

Namibia has successfully attracted major international oil companies (IOCs) and National Oil Companies (NOCs) such as ExxonMobil, Shell, TotalEnergies, Offshore, and QatarEnergy.

Namibia has successfully attracted major international oil companies (IOCs) and National Oil Companies (NOCs) such as ExxonMobil, Shell, TotalEnergies, BWE Offshore, and QatarEnergy.

In collaboration with our international partners TotalEnergies, Shell Namibia & Galp, NAMCOR E&P made significant discoveries of light oil in blocks 2913A (PEL 39), 2913B (PEL 56) and 2813 (PEL 83) in the Orange Basin. These discoveries have firmly established Namibia's offshore margin as one of the world's most prospective exploration regions

In addition to maintaining an average of 10-15% participation stake in 100% of all petroleum exploration licenses issued in Namibia, NAMCOR E&P holds operatorship in five blocks. These blocks are as follows:

- Blocks 211A & 2212B
- Block 2614B
- Blocks 2714A & 2714B
- 2815 & 2915

Among these, three blocks are situated in the Orange Basin, where notable light oil discoveries have been made. While the remaining blocks are located in the Lüderitz and Walvis Bay Basins respectively.

This diversified portfolio of operated blocks underscores NAMCOR's E&P commitment to exploration across various basins in Namibia, aiming to unlock the potential of its hydrocarbon resources.

Therefore, companies and individuals pursuing oil exploration-related activities are cordially invited to consider Namibia as their next hydrocarbon investment destination. With its favorable investment conditions, stable political environment, and proven petroleum potential, Namibia offers lucrative opportunities for exploration and development in the oil and gas sector.

UPSTREAM DEVELOPMENT & PRODUCTION

The Upstream Development & Production Department is built upon NAMCOR's Integrated Strategic Business Plan (ISBP), which is centered on the pursuit of robust international oil-producing assets in politically stable jurisdictions. This pursuit aims to secure long-term sustainable cash flow for the entity's operations, thereby reducing NAMCOR's dependency on discretionary income.

In 2022, significant oil discoveries uncovered potentially substantial oil and gas reserves, prompting a shift in focus. In addition to pursuing producing assets for cash flow, there arose a necessity to build NAMCOR's operatorship competencies. This serves the broader drive towards capacitybuilding and skills transfer in response to the local oil discoveries.

On 12 April 2022, NAMCOR and its partners signed a Sale and Purchase Agreement with Sonangol P&P for the acquisition of a 10% working interest in Block 15/06, a 40% working interest in Block 23 (with operatorship), and a 35% working interest in Block 27, offshore Angola. This transaction is in an advanced stage and is progressing towards completion. NAMCOR also holds an interest in Serica Energy, a well-performing gas-producing asset in the North Sea.

Locally, as the custodian of Namibia's state interest in the petroleum industry, NAMCOR holds participating interest in all the local discovery licenses. The department is actively driving NAMOCR's ESG-conscious development strategy in the currently matured development concepts. Strong technical and strategic partnerships have been formed with world-class International Oil Companies (IOCs) as well as National Oil Companies (NOCs) worldwide.

The operations of the Upstream Development & Production Department are guided by principles of good governance, striving for sustainable and socially responsible investments that adhere to environmental, social, and governance (ESG) standards.

NAMCOR's downstream activities encompass the import, storage, marketing, sale, and distribution of petroleum products within Namibia and throughout the region. With a strategic focus on ensuring the security of fuel and lubricant supplies locally.

Our commitment to the sale of petroleum products extends to diverse sectors including mining, transportation, fishing, and government institutions. In line with our vision for broader accessibility, NAMCOR has an established Retail Network, establishing sustainable retail sites in both urban and rural areas. Presently, NAMCOR operates 19 service stations across Namibia, facilitating convenient access to fuel and lubricants for our customers.

Central to our mission is the cultivation of alternative supply sources and the development of robust supplier networks. By actively pursuing export opportunities and fostering cross-border trade, we aim to generate revenue and enhance economic resilience. As a key player in Namibia's downstream industry, NAMCOR holds a wholesale license, enabling us to import our petroleum products. In addition to our import capabilities, we manage the National Oil Storage Facility in Walvis Bay, boasting a capacity of 75 million liters.

Complementing this infrastructure, we operate a 650,000-liter depot in Otjiwarongo and hold interests in storage facilities located in Keetmanshoop. At NAMCOR, we are committed to driving the growth and sustainability of Namibia's energy sector, underpinned by our dedication to excellence, reliability, and innovation.

In addition to supplying petrol and diesel fuels to bulk customers in industry, we ventured into the fuel retail sector with the opening of our first retail site in August 2019.


