Executive Summary of Bid Evaluation Report for supply and take delivery of oil spill equipment for NAMCOR -NOSF tanker jetty for two main functions Reference number of procurement: G/ONB/NC-03/2023

#### 1. PURPOSE

The purpose of this bid is to provide NAMCOR with Oil Spill Equipment guided by the National oil spill plan in terms of section 9 of the Prevention and Combating of Pollution of the Sea by Oil Act, No. 6 of 1981 which requires the polluter to combat the cost of the pollution it has caused.

#### 2. SCOPE OF SERVICES

The Bidder shall supply and take delivery of oil spill equipment for NAMCOR -NOSF tanker jetty for two main functions.

- Appointment of contractor for the supply, delivery, and commissioning of oil spill equipment's.
- Training of the supplied oil spill equipment's, service, and maintenance thereof.
- The bidder will be required to partake in the emergency drills that will be conducted after the commissioning of equipment and oil spill response training.
- After commissioning of the equipment, NAMCOR will enter in a 3-year level servicing agreement with the successful bidder for the maintenance of the equipment.
- A site acceptance test will be carried out after the commissioning of the equipment. Failure
  of the site acceptance test will result in that NAMCOR will not accept any of the
  equipment that are non-compliant.
